Many US bird populations are in decline, some of which are even on the brink of extinction. Of the 800 species of birds in the United States, 67 are listed as endangered or threatened; another 184 are listed as "species of conservation concern" because they have small distribution, are facing high threats or have a declining population. Hawaiian birds and ocean birds appear most at risk. More than one-third of all US bird species are in Hawaii. However, 71 Hawaiian species have gone extinct since A.D. 300 and about 10 species have not been seen in the past 40 years. The declines of US bird populations can be traced to a variety of factors, including agriculture, climate change, unplanned urban development, and overfishing. In the grasslands, for example, intensified agricultural practices have hurt bird populations. Grassland cannot support many birds if it is overused or burned too frequently. Besides, public lands and parks are mowed too frequently and the grass is too short to provide a habitat for birds.

While many bird species are in decline, some other species are thriving. Research shows that wetland bird species began to increase in the late 1970s, which reflects the importance of the artificial habitats to the survival of many bird populations. The results prove that investment in wetlands has paid off and that it is now necessary to invest similarly in other neglected habitats where birds are undergoing steepest declines.
