Although firefighting is the most \_\_\_47\_\_ aspect of a firefighter's role, and continues to be a primary function of the firefighters' duties, emergency medical response and care have become a large part of the firefighters' daily activities. Emergency medical care, fire prevention, fire education, and community relations occupy a major part of the time on the job. Firefighters are trained to \_\_48\_\_ buildings for hazardous conditions that may result in a fire. Armed with their knowledge of fire hazards and local fire and building laws, they check exit routes, the storage and use of flammable and combustible materials, \_\_49\_\_ of public places, and improper use of equipment or materials in all kinds of buildings. Firefighters are also trained to administer emergency first aid. There are several levels of training: Emergency Medical Technician-Basic (EMT-1), Emergency Medical Technician-Intermediate (EMT-2), and Emergency Medical Technician\_\_50\_\_ (EMT-P). These are the major classifications of Emergency Medical Services Systems. The training and skill requirements are standardized and are based on the academic or practical curriculum respectively in Taiwan.
