In 1881, he went to the Hague and produced his first masterpiece, The Potato Eaters, in 1885. He then attended an art school in Belgium. Inspired by the paintings of Peter Paul Rubens at the school, he was soon off to Paris, where he met Gauguin and found Impressionists like Camille Pissarro. Van Gogh established his personal style of painting during his two years' stay in Paris.

Tired of city life, Van Gogh left Paris and rented a house in Arles in the south of France. Gauguin joined him later in October, but in a quarrel on Christmas Eve, Van Gogh cut off part of his own left ear. He was then kept in a psychiatric hospital for one year. Then, he moved to the home of a physician-artist. But two months later, on July 27, 1890, he shot himself and died.

I think that being adopted is a lot like being left-handed. You just don't notice it unless someone else points it out. I was constantly hearing the comment, "Jason's not really your brother, is he?"
