For sushi aficionados, the essence of the Atlantic bluefin tuna is its fatlaced, butter-soft belly meat, called toro. For those who seek the bluefin from Cape Hatteras off the coast of North Carolina to the frigid waters south of Iceland to the balmy Mediterranean, the fish are a potential bonanza, with choice specimens selling for \$50,000 or more in Tokyo. But the intensifying trade in bluefin may soon empty the waters of this master of the sea. In just the last 35 years, exploding markets for sushi-grade tuna, combined with industrial-scale hunts aided by satellites and spotters in airplanes, have devastated not only the fish but also many fisheries. Dozens of Mediterranean towns that maintained coastal net traps for half a millennium or more are turning away from now-barren waters. Anglers off New England now scour the seas for scattered fish. Most valuable, marine biologists say, is the apparently distinct population of bluefin tuna that breeds in the Gulf of Mexico. The threat to the bluefin was underscored recently by researchers who have tracked hundreds of the fish using electronic tags. They found that the tuna that spawn in the west, which are most severely depleted, are threatened by an everbroadening gantlet of hooks, seines, harpoons, traps and now farm-style pens, in which netted fish are raised and fattened— all to supply the Japanese sushi trade.
