As these languages become more powerful, their use as tools of business and culture increases. As this happens, hundreds of languages that are spoken by a few die out all over the world.

Scholars believe there are around 6,000 languages around the world, but more than half of them could 38. within the next 100 years. Aore is the language native to Vanuatu, located in the Pacific Ocean. Like Catawba before Red Thunder Cloud's death, it is spoken by that island's only remaining native inhabitant; so it, too, will soon be gone.
